**G20 Joint Finance and Health Ministers' Meeting  
29 October 2021 – Rome, Italy**

**G20 Finance and Health Ministers will meet for the first time in a joint meeting** under the **Italian G20 Presidency on Friday 29 October 2021 in Rome**. The meeting will be co-chaired by **Daniele Franco**, Minister for Economy and Finance and **Roberto Speranza**, Minister of Health.

The event will be held at Salone delle Fontane, EUR from 12.00 to 16.30 CEST. A dedicated **media centre will be available to all accredited journalists from Thursday 28 October at 14.00 to Friday 20 October at 23.00 CEST**.

All journalists interested in covering the event in person must apply for **accreditation** via [www.g20.org/accreditation.html](http://www.g20.org/accreditation.html).

**Accreditation is open until Thursday 28 October at 12.00 CEST**

Only accredited journalists will be able to access the Media Centre located at the Palazzo dei Congressi, Largo Virgilio Testa,23 (ingresso Via Ciro il Grande,16), Rome. Please note that journalists already accredited to the G20 Leaders' Summit must submit a new request to access the Media Centre on Friday 29 October 2021.

A Media Handbook with details on confirmed media opportunities and logistical details will be provided to all accredited journalists.

Please be aware that due to the COVID-19 protocol and security measures the Organizers might have to limit the number of accredited journalists coming to the media centre in Rome.

### **Host Broadcaster and Images**

Official media opportunities will be covered by RAI, Italian national Broadcasting Company. Coverage produced by RAI will be made available to all accredited journalists. ### **Media Liaison Officer**

A Media Liaison Officer will be available in the Media Centre to provide assistance to media during the G20 Joint Finance and Health Ministers' Meeting. He/she will assist journalists and media outlets with interview room bookings, interview requests and other logistical information. ### **COVID-19 Procedures**

The Health and Safety Protocol, which will be in place during the G20 events in Rome, specifies that PCR or antigen rapid tests not later than 48 hours are required to access the meeting venue. It also requires that PCR tests or antigen rapid tests be taken every 48 hours, according to the “European Green pass” standard.

All participants are required to wear the FFP2 mask at all times. More detailed information on the COVID-19 procedures will be included in the Media Handbook.
